PLATOON PARTICIPATED IN NUMEROUS COMMUNITY EVENTS, CONTRIBUTING OVER 250 HOURS TO OUTREACH AND VOLUNTEER EFFORTS. THESE INITIATIVES FOCUSED ON RAISING AWARENESS AND PROVIDING EDUCATION ABOUT VETERAN SUICIDE PREVENTION AND SUCCESSFUL MILITARY TRANSITIONS.
